# ANTEGRA Data Warehousing in Alpha Bank

**SERBIA:** After successful aquisition and expansion in Serbian market, management of Alpha bank decided to entrust Asseco SEE (Antegra) with IS migration to a new system. Because of transition to the new system, it was necessary to consolidate data from the previous system in order to get mandatory reports to the NBS and other financial institutions from one place. Even thou this kind of projects last for months, DWH system were ready to use in only 40 days after contract signing and started on September 26<sup>th</sup>.

The Bank also purchased license for Antegra stock exchange system, which started operating also in October. By the end of January, it is expected that transactions from credit card system will start to be loaded as well as overdue and classification calculation.

This was very complex and demanding project, the first one that Antegra and Pexim did together since they became members of Asseco SEE. #### **First Contactless Payment Solution in the Region**

**SERBIA:** In last quarter of 2008, Asseco SEE (Pexim Cardinfo) closed the deal with Banca Intesa a.d. Belgrade for Wincor Nixdorf ATM delivery, EFT POS terminals delivery and implementation of the first contactless payment solution in the region. The deal consists of 15 pieces Wincor Nixdorf ATMs ProCash 2050xe, mobile Hypercom POS terminals with PinPads and 150 pieces of O.T.I. Contactless card readers, SATURN 6000.

By delivering ATMs and POS terminals Pexim Cardinfo expanded current network of Banks card payment infrastructure. In addition of signing a contract of delivery with Bank, the number of ATMs and POS terminals company maintenance is also expanded. Pexim Cardinfo is especially proud that, by reacting on Bank request, they could establish infrastructure and all technical conditions for first contactless Maestro®PayPass<sup>™</sup> technology which enables fastest payment in a very safe and simple way. Pexim Cardinfo once again confirmed the leading position as service provider in payment card business and continued to follow up technical requests of fast expanding region.

#### Asseco SEE (Pexim Cardinfo) Wins the Deal

**SERBIA:** After long struggle with competitors in last quarter of 2008, Asseco SEE (Pexim Cardinfo) won the deal with Postal Savings Bank from Serbia for Wincor Nixdorf ATM delivery, consisting of 80 pieces of ProCash 2150xe and 20 pieces of ProCash 2100xe. Postal Saving Bank is our new client, and has until now used NCR ATM's. This is the first contract in which Pexim Cardinfo is renting ATM's to customer through operational leasing. In addition of signing a contract for delivery with the Bank, Pexim Cardinfo also signed a technical support contract for Proactive maintenance of ATM's including ProView software for ATM monitoring. Currently, the project is in the phase of ATM installations across the country.



#### Asseco SEE (Pexim) Finalized One of the Largest IT Projects in the Region

**SERBIA:** Asseco SEE (Pexim) and Komercijalna banka finalized implementation of the new bank's IT System. The project started a year ago and was planned to be completed in December 2008. 

banka has already gained first benefits of new IT System. Since April this year, system for international bank's operations is in production, which increased efficiency in the work thru high degree of STP and cost consolidation in SWIFT domain network. Besides, back-office system for corporate loans and deposits is in production since August. In this segment, there is also increased efficiency with flexibility and agility in domain of creating new products and services for the bank's clients. After completion of the last phase, which was consisting of branch front office for retail and corporate customers, Komercijalna banka got a modern and efficient IT System which will secure lower costs, higher efficiency and agility on market.



#### **Core and BI customizations in six Macedonian Banks**



**MACEDONIA:** Asseco SEE (Pexim) had signed act of amend with Ohridska Bank SG Group, NLB Tutunska Bank and Export&Credit Bank Skoplje, Stater Bank Kumanovo, Stopanska Banka Skopje and TTK Bank Skopje due to new classification of accounts and changed methodology in accounting for IFRS NBRM. This changes will address Pexim's core and BI solutions (Business Intelligence – IFRS Compliance), including new classification process implementation.

First phase of the project, Technical Acceptance is finalized and currently period of BI stabilization system is in process. Also, production of new Core system is scheduled for the beginning of this year because of new classification of accounts and changed methodology in accounting for IAS, but timeline is depending of banks finishing their last year data processing. The second faze, Technical Acceptance/Production can start when all those conditions are fulfilled. Operability of the system is expected in the mid 2009.
