

10/2011 Decrease of Asseco Poland S.A. portion in shares of Asseco South Eastern Europe S.A.

Warsaw, 6 July 2011

The Management Board of Asseco South Eastern Europe S.A. ("Company") announces that as a result of the increase share capital in Company registered by the District Court in Rzeszów, on 28 June 2011 in connection with the issuance of 902.119 shares series T with a nominal value of PLN 10 each to the amount of PLN 518,942,510.00 which is divided into 51.894.251 shares and which is divided into the same number of votes at a general meeting of the Company, portion of Asseco Poland S.A. ("ACP") shares in the share capital of the Company has been reduced.

Prior to the increase of the share capital Asseco had 26.494.676 shares of the Company giving a total of 51,96% of share capital and entitling to 51,96% of votes at a general meeting of the Company.

After the capital increase as described above Asseco has 26.494.676 shares of the Company giving a total of 51,06% of share capital and entitling to 51,06% of votes at general meetings of the Company.
